- Part of the data is collected to ensure error-free provision of the website. Other data may be used to analyze vour user behavior.

## REVOCATION OF YOUR CONSENT TO DATA PROCESSING.

# RIGHT TO OBJECT TO DATA COLLECTION IN SPECIAL CASES AND TO DIRECT ADVERTISING (ART. 21 DSGVO\*)

- If data processing is carried out on the basis of Art. 6(1)(e) or (f) DSGVO\*, you have the right to object to the processing of your personal data at any time on grounds relating to your particular situation; this also applies to profiling based on these provisions. If you object, we will no longer process your personal data concerned unless we can demonstrate compelling legitimate grounds for the processing which override your interests, rights and freedoms, or the processing serves the purpose of asserting, exercising or defending legal claims (objection under Article 21(1) DSGVO\*).

# 4. DATA COLLECTION ON OUR WEBSITE

#### **COOKIES**

- Some of the web pages use so-called cookies. Cookies do not cause any damage to your computer and do not contain viruses.
